Pursuant to the bye-laws of the Company, the Board may fill any casual vacancy in the office of the auditor of the Company. Following the resignation of McMillan Woods, the Board is in the process of identifying a new auditor to fill the vacancy as soon as possible. Further announcement in relation to the appointment of the Company's new auditor will be made by the Company as and when appropriate in accordance with the Listing Rules.
