### **POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 1 JUNE 2017**

The Board is pleased to announce that at the AGM held on Thursday, 1 June 2017, all proposed resolutions set out in the notice of AGM dated 28 April 2017 (which has been incorporated in the circular of the Company dated the same date) were duly passed by Shareholders by way of poll.

Reference is made to the circular of Rosedale Hotel Holdings Limited (“**Company**”) dated 28 April 2017 (“**Circular**”). Capitalised terms used herein shall have the same meanings as those defined in the Circular unless the context requires otherwise.

#### **POLL RESULTS OF THE AGM**

The Board is pleased to announce that at the AGM held on Thursday, 1 June 2017, all proposed resolutions (“**Resolutions**”) set out in the notice of AGM dated 28 April 2017 were duly passed by Shareholders by way of poll.

As at the date of the AGM, the total number of Shares in issue was 789,211,046 Shares, which was also the total number of Shares entitling Shareholders to attend and vote on the Resolutions at the AGM. There were no Shares entitling Shareholders to attend and abstain from voting in favour of the Resolutions at the AGM pursuant to Rule 13.40 of the Listing Rules and no Shareholders were required under the Listing Rules to abstain from voting at the AGM. No parties had stated their intention in the Circular to vote against or abstain from voting on any of the Resolutions at the AGM.

Tricor Secretaries Limited, the branch share registrar and transfer office of the Company in Hong Kong, was appointed by the Company as the scrutineer for the vote-taking at the AGM.
