UNUSUAL SHARE PRICE AND TRADING VOLUME MOVEMENTS

This announcement is made in connection with the increases in the price and the trading volume of the shares of the Company today. The Directors are not aware of any reasons for such increases save that the Company has been notified today by a non-executive director that a total of 140,000,000 shares of the Company have been disposed today.

This announcement is made at the request of The Stock Exchange of Hong Kong Limited.

The Directors (the "Directors") of Wing On Travel (Holdings) Limited (the "Company") have noted the increases in the price and the trading volume of the shares of the Company today and wish to state that the Directors are not aware of any reasons for such increases, save that the Company was informed today by Mr. Chan Yeuk Wai, a non-executive director of the Company, who is also a director and a shareholder of Hounslow Limited ("Hounslow"), one of the substantial shareholders of the Company that a total of 140,000,000 shares of the Company which were beneficially owned by Hounslow and such shares were pledged to a financial institution, representing approximately 3.2% of the total trading volume of the shares of the Company today, were disposed in the market at a price between HK\$0.040 to HK\$0.041 per share.

Save as disclosed in the announcement regarding the unusual share price and trading volume movements of the Company dated 16 November 2004, the Directors confirm that there are no negotiations or agreements relating to intended acquisitions or realisations which are discloseable under Rule 13.23 of the Listing Rules, neither is the Board aware of any matter discloseable under the general obligation imposed by Rule 13.09 of the Listing Rules, which is or may be of a price-sensitive nature.
